5. Oil, Gas & Energy Investments



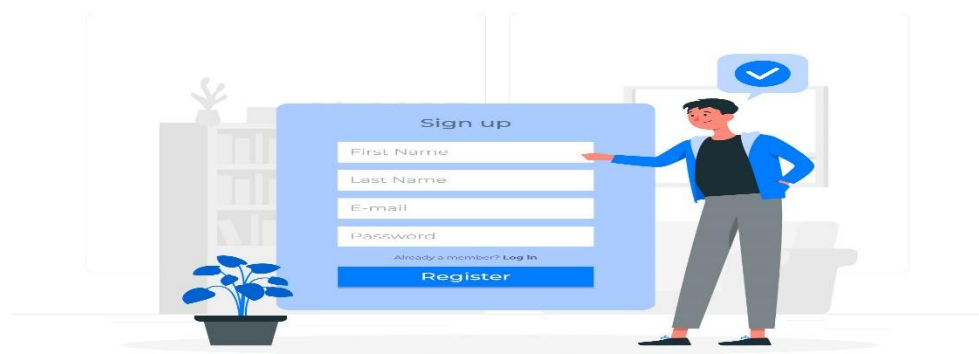
